The Council discussed a request for putting a Handicap Parking Stall in from of Denver Main Street Plaza. The Council wanted more input on the need for the Handicap Parking Stall before making a decision.

Instead of having a City of Denver Facebook Page Council Members felt using the City's Webpage to communicate messages to the public would be the best resource. The City uses the Entrance Sign, the Quarterly Newsletter, the Denver Forum, the Mayor's Column in the Denver Forum and the City of Denver Webpage to communicate with its citizens.

AECOM submitted a Cost Estimate in the amount of \$202,000 for the State Street Bridge Deck Repair Project.

In Other Business Councilwoman Scharnhorst had a request to use the Community Room for Seniors in Motion. She will work on getting additional information. Councilman Peterson requested Prestien Drive and the other Seal Coated Streets to be have the Street Sweeper sweep up the loose chips.
