The first meeting of November for the Denver City Council, Bremer County, Iowa was held on Monday November 7, 2016 at the Denver City Hall Council Chambers. Council members present were Derek Gustafson, Jeremie Peterson, Mark Richmann, Mary Scharnhorst and Joel Wikner. There were four people in attendance.

Mayor Diercks called the meeting to order at 7:02 p.m.

Motion Wikner, second Peterson to approve the Agenda. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

Motion Richmann, second Scharnhorst to approve the Minutes of October 17, 2016. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

There was no Public Forum.

Motion Peterson, second Richmann to Open the Public Hearing to consider Approving Plans, Specifications and Form of Contract and Notice to Bidders, Fixing Amount of Bid Security and Bid Proposals for the Schneider Street Improvement Project. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None. The Public Hearing was Opened at 7:03 p.m.

During the Public Hearing Larry Farley explained Lyle TeKippe of Fehr-Graham Engineering had Prepared Plans, Specifications, Form of Contract, Notice to Bidders and set 5% as the Amount of Bid Security from each bidder and we received three proposals on November 3, 2016 at 10:00 a.m. at the Denver City Hall for the Schneider Street Improvement Project. The three bids submitted were as follows:

Denver Underground & Grading Inc. \$142,534.20 Baker Concrete & Excavating \$176,925.20 Mehmert Tiling Inc. \$181,451.88

Engineer Lyle TeKippe submitted a letter to the City Council recommending they accept the low bid submitted by Denver Underground & Grading Inc. in the amount of \$142,524.20. Randy Thurm was confused as to how this project was proceeding. The Preliminary Plat for the Schumacher Third Addition, Second Phase has been approved but the Final Plat for the Subdivision has not been approved. Mr. Thurm felt the Final Plat of the Schumacher Third Addition, Second Phase should be approved by the Denver Planning & Zoning before the infrastructure is installed. Mr. Thurm also felt Schneider Street was part of the Schumacher Third Addition, Second Phase. Larry Farley explained that previous subdivisions have been approved in two ways, with the most recent subdivision Denver Development Plaza 2 had the Preliminary Plat approve and Final Plat approved and then the infrastructure was installed and the other way that has been used primarily in housing subdivisions was to approve the Preliminary Plat then the developer installs the infrastructure and then the Final Plat is approved and recorded. This is one way the City has worked with housing developers because the County Assessor changes the classification of the property after it is recorded as a housing subdivision instead of Ag Land. Larry Farley also explained that Schneider Street is a platted City Street but not an improved City Street. The four lots in the Schumacher Third Addition, Second Phase lie right along the Schneider Street R.O.W. and the Denver Community School District owns the other side of Schneider Street. The Schumacher Subdivision will be paying for 50% of the street improvements and City Council Members are working with the Denver Community School District on an agreement to pay for the other 50% of the street

improvements. Mr. Thurm didn't realize that Schneider Street was a platted City Street. Mayor Diercks asked if there were any further comments for or against the Schneider Street Project. There were none.

Motion Scharnhorst, second Wikner to approve Resolution No. 96-2016 Awarding Contract for the Schneider Street Improvement Project to Denver Underground & Grading Inc. in the amount of \$142,534.20. ROLL CALL VOTE: AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

Brenna Fall of Snyder & Associates presented the qualifications for her engineering firm to perform the services necessary to complete the 2018 South State Street Reconstruction Project. Snyder & Associates has completed numerous projects involving Federal Aid. She explained the Professional Services Agreement for the project and feels her firm has a good understanding of what needs to get done. Ms. Fall will begin working toward having the project included in the Iowa Department of Transportation December 2017 Letting Date. Phase I is the Concept Phase at a cost of \$25,000, Phase II is the Topographic Survey at a cost of \$20,000, Phase III is the Design and Plan Preparation Phase including Special Assessments, Permits and Bid Documents at a cost of \$60,000. The total cost of Engineering Services to Bid Letting is \$105,000 with construction planned for 2018.
