The first meeting of December for the Denver City Council, Bremer County, Iowa was held on Monday December 5, 2016 at the Denver City Hall Council Chambers. Council members present were Derek Gustafson, Jeremie Peterson, Mark Richmann, Mary Scharnhorst and Joel Wikner. There were seventeen people in attendance.

Mayor Diercks called the meeting to order at 7:00 p.m.

Motion Richmann, second Scharnhorst to approve the Agenda. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

Motion Peterson, second Richmann to approve the Minutes of November 21, 2016. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

There was no Public Forum.

Denver Girl Scout Troop #6650 represented by Mia Leonhart, Savana Kastli, Allison Sessler, Ashley Ferson and Krza Iverson presented plans to construct a Book Nook at City Park near the Cyclone City Playground. A Book Nook is a place to store reading materials such as books and magazines to read in the park. They plan to use leftover materials from the playground construction project.

Motion Wikner, second Gustafson to approve Girl Scout #6650 plans to construct a Book Nook in City Park. AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

Ambulance Crew Chief and Waverly E.M.S. Coordinator Jim Schutte updated the Council on plans for a Bremer County Wide E.M.S. Service. All of the ambulance services in Bremer and Butler County are experiencing difficulty finding enough qualified volunteers to cover all of the on-call hours and the amount of training required for volunteers is making it difficult to keep staffing levels needed to properly operate the ambulance service. The ambulance services in Bremer County have started discussing how to improve their service and looking for how to best provide service in the future. Jim Schutte explained the benefits of going to a Bremer County-Wide Ambulance Service that includes coordinated purchasing of supplies, using one billing service ambulances would be dispatched out of four locations in Bremer County. There are lots of questions that remain unanswered at this time and how the organization would be structured. No decision was made on the Bremer County Ambulance Service.

Ambulance Crew Chief Amy Gehrke presented two bids for a new ambulance. Alexis Fire Equipment was in the amount \$201,214 and Klocke's Emergency Services was in the amount of \$205,127. A third vendor dropped out of the bidding early in the process. The Alexis Fire Equipment Ambulance has the following options; the Ford F-450 Base Bid Ambulance and accessories is \$177,772, Stryker Power Load System \$21,134, 12-volt Power Inverter \$1,233, Attendant Seat/Child Seat \$1,075, striping and paint is included in the base bid. Delivery time is five months after the order is received.

Motion Richmann, second Peterson to approve Resolution No. 103-2016 to purchase a 2017 Ford F-150 Ambulance and Options for the Denver Ambulance Service from Alexis Fire Equipment in the amount of \$201,214. ROLL CALL VOTE: AYES: Gustafson, Peterson, Richmann, Scharnhorst, Wikner. NAYS: None.

Wes Gielau was present to request the Council to consider future housing incentives. There are two spec homes that are not sold yet and three lots for twin homes and one lot remains for a single-family home.

Mr. Gielau felt Denver residents have benefitted from the housing incentives and the Denver School District has benefitted from the incentives by gaining 15-20 new students from residents moving out of their single-family homes and into the twin homes. Councilman Richmann is concerned about the City incurring more debt and supports a re-batement program. Scott Hintz requested the Tax Abatement Incentive to be re-bated to the Home Builders since they are the ones taking the risk. The current Tax Abatement Program goes to the Homeowner over a set number of years based on the property valuation as set by the Bremer County assessor. He would like to continue building twin homes in Denver instead of Dike or Waverly. Al Hintz informed the Council that the rest of the Home Building Contractors would prefer to have the tax abatement sent to them over the specified number of years. The program has allowed Denver to keep its elderly population in town. Larry Farley will contact the bond attorney to see if re-bating the property taxes to the Home Building Contractors was allowable.
