The third meeting of September for the Denver City Council, Bremer County, Iowa was held on Monday September 24, 2018 at the Denver City Hall Council Chambers. Council members present were Gavin Carman, Sean Hartman, Jeremie Peterson, Mark Richmann, Joel Wikner. Councilman Richmann arrived at 6:05 p.m. and Councilman Peterson arrived at 6:07 p.m. There was no one in attendance.

Mayor Diercks called the meeting to order at 6:00 p.m.

Motion Hartman, second Wikner to approve the minutes of September 17, 2018. AYES: Carman, Hartman, Wikner. NAYS: None.

Mayor Diercks opened the discussion to consider an Outdoor Service Application for W-KEY Inc. d/b/a Whiskey Junction request for an Outdoor Service Application on September 29, 2018 between the hours of 6:00 p.m. to 1:00 a.m. Councilman Carman felt the City Council has been trying to get the owner of Whiskey Junction Floyd Liddle to work with the neighboring businesses now we have to have a Special City Council Meeting and no one from the business shows up to discuss the event. Councilman Richmann informed the Council that he has heard about Whiskey Junction Floyd Liddle making comments in the bar about destroying Denver. Councilman Hartman wanted it known that if the Outdoor Service Application is approved for Whiskey Junction the taxpayers will be paying for overtime for police protection, the expense of an extra City Council meeting, the expense of submitting the Outdoor Service Application to the Iowa Department of Alcoholic Beverages Division, and then the owner of Whiskey Junction Floyd Liddle is making threats about destroying the whole city. The Council felt it should be consistent with how the Denver Breakaway Days handles their Outdoor Service Application at Prestien Park and that should serve as a model for similar events in Denver like the one Whiskey Junction is asking for the City Council to approve tonight. The Council put five conditions on Whiskey Junction to follow in order to conduct this event.

- 1. The fenced area can only be set on the sidewalk to the end of Whiskey Junction Building East property line then the fence needs to on the street and not block the sidewalk to the alley to give the other business owners access to their businesses.
- 2. Two Portable Toilets inside the fenced area.
- 3. Must Issue wristbands to everyone of legal age inside the fenced area.
- 4. Entrance/Exit area to be guarded by Whiskey Junction Employees.
- 5. Music goes off at Midnight and the Outdoor Service Area is closed at 1:00 a.m. on September 30, 2018.

Motion Wikner, second Richmann to approve the Outdoor Service Application for W-KEY Inc. d/b/a Whiskey Junction for September 29, 2018 starting at 6:00 p.m. until September 30, 2018 at 1:00 a.m. with the following five conditions; 1. the fenced area can only be set on the sidewalk to the end of Whiskey Junction Building East property line then the fence needs to on the street and not block the sidewalk to the alley to give the other business owners access to their businesses, 2. two Portable Toilets inside the fenced area, 3. must Issue wristbands to everyone of legal age inside the fenced area, 4. Entrance/Exit area to be guarded by Whiskey Junction Employees, 5. Music goes off at Midnight and the Outdoor Service Area is closed at 1:00 a.m. on September 30, 2018. AYES: Carman, Hartman, Peterson, Richmann, Wikner. NAYS: None.

Motion Carman, second Richmann to close East Main Street to the alley and sidewalk next to the Whiskey Junction Building beginning at 5:00 p.m. on September 29, 2018 until 1:00 a.m. on September 30, 2018. AYES: Carman, Hartman, Peterson, Richmann, Wikner. NAYS: None.

Motion Hartman, second Wikner to approve Resolution No. 61-2018 to purchase a Miller Wire Welder from Superior Welding Supply Co. in the amount of \$3,147.64 less a \$400 rebate to make the net purchase price of \$2,747.64.
